

1. Introduction

This privacy policy describes the personal data that NRL Hunter UK receives and/or processes (which may include collecting, organising, structuring, storing, using, or disclosing) when you interact with NRL Hunter UK, as a member.

2. What Personal Data We Receive

Personal Data is any information from or about an identified or identifiable person but does not include aggregated or anonymised information. We receive Personal Data when you use or interact with NRL Hunter or our online services, which may include the following categories:

1. **Profile and Contact Information:** We receive contact or other profile information when you sign up for or interact with NRL Hunter UK, which may include name, date of birth, telephone number, email address, profile picture, or other information you choose to provide us. We may link this information to the different devices or accounts you use when you interact with NRL Hunter UK.
2. **Payment Information:** We receive payment information when you use the Range Mate and Stripe facility or make a purchase through the NRL Hunter UK website, such as your payment card number and expiration date.

3. How We Use Your Personal Data

NRL Hunter UK uses Personal Data for the following purposes depending on how you interact with us or which services you use and based on your activity across all devices where you log in to, or interact with, NRL Hunter UK via the Range Mate platform:

1. **Communicate with You:** To communicate with you about NRL Hunter activity, including about event updates, your account, and changes to our policies and terms. We also use your information to respond to you when you contact us.
2. **Authentication, Integrity, Security, and Safety:** To authenticate your account, provide a secure payment experience, and to detect, investigate, and prevent malicious conduct, fraudulent activity or unsafe experiences, address security threats, protect public safety, and secure NRL Hunter UK systems including Range Mate.
3. **Legal Reasons:** To comply with applicable law or respond to valid legal process, including requests from law enforcement or government agencies, to investigate or participate in civil actions, litigation, or other adversarial legal proceedings, and to enforce or investigate potential violations of our terms or policies.
4. **Sharing your information:** We may share your information with a range/venue you have booked onto as a NRL Hunter UK customer for event planning and management. They will not hold all of your information, merely your name for the purpose of making a range log or a record of your attendance. We will NOT share your information with any other third party without your permission. The Range Mate platform acts as a 'Data Processor', more information about this can be found [via this link](#).

4. Third Party Partners & Integrations

Parts of the Range Mate system may link to third party services at your request to provide you with discounts. NRL Hunter UK and Range Mate do not own or control these third parties. When you interact with these third parties and choose to use their services, your use is subject to the privacy policies of those providers. You must decide to utilise this link, if you do not then no link will ever be made by the Range Mate system.

5. Your Privacy Rights and Choices

You may have certain rights to manage your Personal Data depending on where you live. Depending on your jurisdiction, the following rights may apply, subject to certain exceptions:

Ultimately you retain the right to contact us and request action in relation to the below with immediate effect -

1. **Access and Portability:** Right to request access to your Personal Data.
2. **Correction / Rectification:** Right to correct inaccurate or incomplete Personal Data in certain circumstances.
3. **Deletion / Erasure:** Right to delete Personal Data about you.

You can also update your account information or request to deactivate or delete your account directly through your in-app (Range Mate) settings. You may have additional rights available to you.

6. Retention

We retain Personal Data for as long as we have an ongoing business need to do so (e.g., to provide NRL Hunter UK services, to comply with applicable legal, tax, or accounting requirements, for security and fraud detection or prevention, or in connection with backup or disaster recovery processes), unless a different retention period is permitted or required by applicable law.

The criteria used to determine our retention periods include the following:

1. The length of time we have an ongoing relationship with you and provide NRL Hunter UK services to you (for example, for as long as you have an account with us or keep using our services);
2. Whether you modify or delete your information through your accounts.
3. Whether NRL Hunter UK has a legal obligation to keep the data (for example, certain laws require NRL Hunter UK to keep records of your transactions for a certain period of time); or
4. Whether retention is advisable in light of our legal position (such as in regard to the enforcement of our agreements, the resolution of disputes, the applicable statutes of limitations, litigation, or regulatory investigation).

7. DELETION

We will delete your data completely from our systems when you cease to be a member, either through inactivity, failing to renew or ending your membership, or at your request to do so. Should you request your data to be deleted you will be unable to access NRL Hunter UK services.
